	For the installation or relocation of each forced-air or gravity-type furnace or burner, including ducts and vents attached to such appliance over 100,000 Btu/h (29.3kW)			
	For the installation or relocation of each floor furnace, including vent			
	For the installation or relocation of each suspended heater, recessed wall heater, or floor mounted unit heater			
<b>2</b>	<b>Appliance Vents – (bath, laundry fans included)</b>			
	For the installation, relocation or replacement of each appliance vent installed and not included in an appliance permit			
<b>3</b>	<b>Repairs or Additions</b>			
	For the repair of, alteration of, or addition to each heating appliance			
<b>4</b>	<b>Boilers, Compressors and Absorption Systems</b>

	For the installation or relocation of each boiler or compressor over 15 horsepower (52.7kW) to and including 30 horsepower (105.5kW), or 500,000 Btu/h (146.6kW) to and including 1,000,000 Btu/h (293.kW)			
	For the installation or relocation of each boiler or compressor over 30 horsepower (105.5kW) to and including 50 horsepower (176kW), or 1,000,000 Btu/h (512.9kW)
